Zimmer, both of Boston, in the County of Suffolk and Commonwealth aforesaid, the receipt whereof is hereby acknowledged, do hereby G I V E, GRANT, CONVEY unto the said Nellie M. Zimmer, and GAIN, SELL and Josephine A. Zimmer, a certain parcel of land including all buildings thereon, situate on the northeasterly shore of Nipmuck Pond, so called, in MENDON, in said County and Commonwealth, being all the same premises described in deed of Luther E.
