WARRANTY DEED

The FEDERAL FARM MORTGAGE CORPORATION, a corporation established under the laws of the United States of America and having its office and usual place of business in the City of Washington, District of Columbia, for consideration paid grant to CHESTER C. SHATTUCK of Mendon, Worcester County, Massachusetts, with warranty covenants the land in the Towns of Mendon and Blackstone, County of Worcester, in the Commonwealth of Massachusetts, as follows:
