## **QUITCLAIM DEED**

We, Robert E. Klein, Jr. and Lori H. Klein, of Mendon, Worcester County, Massachusetts

For consideration of TWO HUNDRED FIFTY FIVE THOUSAND AND 00/100 DOLLARS (\$255,000.00) paid

Grant to John L. Carpenter and Maryanne Carpenter, Husband and Wife, as Tenants by the Entirety, of 25 Taft Avenue, Mendon, Worcester County, Massachusetts

## with Quitclaim Covenants

Two certain parcels or tracts of land, together with the buildings thereon, situated in Mendon, Worcester County, Massachusetts, bounded and described as follows:

PARCEL 1: A certain parcel of land situated on the northeasterly shore of Nipmuck Pond, so called, in said Mendon, being shown as Lot entitled Bartlett on a plan of land recorded with the Worcester District Registry of Deeds in Plan Book 31, Plan 50, bounded and described as follows:

Beginning at a stake at the shore of said Nipmuck Pond, said stake being at a point measured about 50 feet southerly from land now or formerly of Thomas F. Matthews; thence running N. 79° 35' E., 94 feet to a stake; thence S. 10° 25' E., 50 feet to a stake; thence S. 79° 35' W. 100 feet to the shore of the pond, said line running through a drill hole in a stone which drill hole is 66.25 feet from the stake at the starting point of said line; thence northerly along the shore of the pond about fifty feet to the point of beginning. Said land is bounded on three sides by other land now or formerly of Mildred I. Nelson and on the fourth side by said pond.

Together with such rights of way, but none other, to and from the premises over an ancient town way along or near the shore of said pond as said Mildred I. Nelson is entitled to grant.

Subject to a right of way to the public over a portion of the above described premises, two rods in width, measured from the high water line of the shore of said pond.
