Foreign Will.

I, Daniel A. Cook of Providence, County of Providence, State of Rhode Island, being of sound mind and memory, do make, and publish and declare, this to be my last will and testament, to wit:

First- All my just debts and funeral expenses shall be first fully paid.

Second-All the income, or so much of it, as may be necessary for the comfortable maintenance of my beloved wife Harriet O. Cook shall be used by my executor, (who shall also be the Guardian of my wife ) for her benefit.

Third- If the income of my estate shall not be sufficient for the comfortable maintenance of my wife then I give to my executor full power to sell any or all of my real estate, or any personal property of which I may die possessed, the same to be used as much as needs be for my wife's needs. He shall have full power by the consent of the Probate Court to change any property of which I may be possessed at the time of my death and invest the same in some other manner if the change seems likely to be of advantage to my estate.

My executor shall whenever it is desirable to sell any real estate of which I die possessed have full power to give a deed therefor. Any stocks

bonds, or any personal property of whatsoever nature my executor shall have full power to sell if in his judgment it becomes necessary for the comfortable maintenance of my wife.

Fourth- It shall be the meaning of this will that every dollar of my estate shall be used if needs be in giving to my wife a comfortable maintenance during her life.

Fifth- After my wife's decease should there be after the payment of all her debts, funeral expenses and all just claims against her, any property left, I desire that it be given share and share alike to the following persons.

My sister Naomi of Tacoma Ill. wife of Charles Cook. My sister Louisa wife of Davis Gregory of Norton Mass. My sister Sarah of Milford Mass. wife of Davis B. Cook. My sister Olive wife of Charles Ford of Worcester Mass. My sister Vienna wife of William R. Dean of Worcester Mass. My brother B. Monroe Cook of Worcester Mass. My niece Eva L. Angell wife of Frank Angell of South Woodbury Vermont.

Sixth- Should any of these persons named who are to receive some portion of my estate in case there should be anything left after my wife's death, die before my wife then the share of that person or persons shall fall to those who survive share and share alike. Should all of the persons thus for named in my will die before my wife's decease and there should be property left, I desire that it be equally divided among the children of my sister's named in this will, the children of brother Monroe or B. Monroe Cook and the children of Eva L. Angell. That is such of them as may be living at my wife's decease.

Lastly- I nominate and appoint Davis Gregory of Norton Mass. to be the executor of this my last will and testament without bonds and I hereby revoke all former wills by me made.
