# To all People to whom these

Presents shall come, Greeting. KNOW YE, That I Seth Taft of Mendon in the County of Worcester  
Commonwealth of Massachusetts Gentleman

For and in Consideration of the Sum of two hundred and fifty pounds  
to me in Hand before the sealing hereof, well and truly paid by Elijah Taft of the Town  
County & Commonwealth aforesaid Yerman —

the Receipt whereof I do hereby acknowledge, and my self therewith fully satisfied and con-  
tent; and thereof and of every Part and Parcel thereof, do exonerate, acquit and discharge  
*him* the said Elijah Taft his —

Heirs, Executors, and Administrators, forever by these Presents: HAVE given, granted, bargain-  
ed, sold, aliened, conveyed and confirmed; and by these Presents, Do freely, fully, and absolute-  
ly, give, grant, bargain, sell, aliene, convey and confirm, unto *him*, the said Elijah Taft his —

Heirs and Assigns forever, *For equal half of all my lands and*

*building, both quantity & quality except a piece of wood land adjoining Land Abraham Staples land*  
*and bounded as followeth lying in two pieces the first bounded Southwardly by land of the heirs of Caleb*  
*Taft deceased, Eastwardly by the Godfathers land Northwardly partly by George Tafts land & sons Taft's land &*  
*by the road to the above said heirs land always excepting and referring to the use of the publick*  
*the road leading through the groves — The other piece lying on the Westwardly side of the Road*  
*leading to the South Parish Meeting house beginning at a heap of stones & corner of Dewart*  
*Thompson's land being the Northeast corner of said premises thence Westwardly by said Thompson's*  
*land to a heap of stones at Laban Fairbanks land being the Northwest corner thence South*  
*wardly & bounded Westwardly partly by said Fairbanks land and partly by land of Seth Taft Junr.*  
*to a heap of stones at another piece of said Thompson's land being the Southwest corner thence*  
*Westwardly and bounded Southerly partly by said Thompson's land and partly by a road until it*  
*comes to the aforesaid road thence turning Northwardly by said road to the first bound*  
*the whole containing about one hundred and twenty Acres by the same more or less*  
*Also a two acre right in the common and undivided land in the former Township*  
*of Mendon from and after the tenth Division —*

To HAVE and to HOLD the said granted and bargained Premises, with all the Appurtenances, Priv-  
ileges and Commodities to the same belonging, or in any wise appertaining, to *him* the said Elijah  
*Taft his —*

Heirs and Assigns forever. To *him* and *his* only proper Use, Benefit and Behoof forever. And I the said Seth Taft

for *myself my* Heirs, Executors and Administrators, do Covenant, Prom-  
ise, and Grant to and with *him* the said Elijah Taft his —

Heirs and Assigns, that before the sealing hereof, I am the true, sole and lawful Owner of the  
above bargained Premises, and *am* lawfully seized and possessed of the same in *my* own proper Right,

as a good, perfect, and absolute Estate of Inheritance in Fee Simple: And have in *myself* good Right,

full Power and lawful Authority, to grant, bargain, sell, convey and confirm said bargained Premises

in Manner as aforesaid: And that *the said Elijah Taft his —*

Heirs and Assigns, shall and may from Time to Time, and at all Times forever hereafter, by Force  
and Virtue of these Presents, lawfully, peaceably and quietly Have, Hold, Use, Occupy, Possess and  
Enjoy the said demised and bargained Premises, with the Appurtenances, free and clear, and freely  
and clearly acquitted, exonerated and discharged of, from all and all Manner of former or other Gifts,  
Grants, Bargains, Sales, Leafes, Mortgages, Wills, Entails, Jointures, Dowries, Judgments, Execu-  
tions or Incumbrances, of what Name or Nature foever, that might in any Measure or Degree ob-  
struct or make Void this present Deed.

*Furthermore, I the said Seth Taft*

for *myself my* Heirs, Executors, and Administrators, do Covenant and Engage the above demised  
Premises to *him* the said Elijah Taft his —

Heirs and Assigns against the lawful Claims or Demands of any Person or Persons whatsoever, forever

hereafter to Warrant, Secure and Defend by these Presents.

*hand and seal this second Day of August in the year of our Lord seventeen hundred*  
*and eighty two —*
