 his heirs executors or administrators pay to the said Knight Make-
 peace his heirs executors administrators or assigns the sum of six
 hundred dollars be paid in in six annual payments the first
 to be paid in two years from date with interest on the same
 annually the sum being included in six notes of hand of this
 date then this deed as also six certain notes of hand bearing even
 date with these presents given by the said Eliab Snow to the said
 Knight Makepeace to pay the same sum of six hundred dollars
 at the times aforesaid shall be void otherwise shall remain in
 full force. I'm witness whereof the said Eliab Snow have hereunto
 set my hand and seal this eighth day of April in the year of
 our Lord one thousand eight hundred and twenty three.
