K NOW ALL MEN BY THESE PRESENTS that I, Franc Lusier, of Mendon, in the County of Worcester and Commonwealth of Massachusetts, in consideration of One Dollar and other valuable considerations, paid by Amoret Wise, of Hopedale, County aforesaid, the receipt whereof is hereby acknowledged, do hereby G I V E, CONVEY BARGAIN, SELL and GRANT. the said Amoret Wise three certain tracts or parcels of land situated in said MENDON, and the first of said tracts is bounded and described as follows, namely: A certain tract of land with all the buildings thereon, situated upon the southeasterly side of the road leading from Alanson Taft's house to the house of Warren Ross and bounded as follows viz: Beginning at the southwesterly corner of the premises hereby conveyed at land of Austin A. Taft; thence southeasterly as the wall and fence now stand to a corner; thence turning and running northeasterly as the wall now stands, bounded southeasterly by land of James Broughey to a corner; thence turning and running northwesterly as the wall and fence now stand, bounded northeasterly by land of Austin A. Taft to the road aforementioned; thence turning and running southwesterly as the road now runs to the place of beginning; also a shoemakers shop standing on the northwesterly side of the road opposite the barn situated on the premises above described.
