## CHAPTER 183 SEC. 6 AS AMENDED BY CHAPTER 497 OF 1969

The full consideration shall mean the total price for the conveyance without deduction for any liens or encumbrances assumed by the grantee or remaining thereon. All such endorsements and recitals shall be recorded as part of the deed. Failure to comply with this section shall not affect the validity of any deed. No register of deeds shall accept a deed for recording unless that the conveyance with the recorded as part of the deed. it is in compliance with the requirements of this section.
