with QUITCLAIM COVENANTS

The land with the buildings thereon, situated in Mendon, Worcester County, Massachusetts, on the corner of Hastings and Elm Streets and bounded and described as follows:

Beginning at a point on the Southeasterly side of Hastings Street at the intersection with the Northeasterly side of Elm Street, said point being forty-six and twenty hundredths feet (46.20') Northeasterly by the Southeasterly side of Hastings Street from a Massachusetts Highway Bound;

Thence N. 39° 36' E. seventy-two feet (72.00') by the Southeasterly side of Hastings Street to land formerly of Brown, now or formerly of Rapp;

Thence S. 50° 20' 50" E. fifty-seven and sixty-seven hundredths feet (57.67');

Thence S. 48° 42' E. one hundred twenty-one and seventy-eight hundredths feet (121.78') to land of Shattuck; the last two (2) courses being land formerly of said Brown;

Thence S. 33° 17' 10" W. sixty-five and twenty-three hundredths feet (65.23') by Shattucks' land to the Northeasterly side of Elm Street;
