Know all men by these presents that I Sarah Prince of Mendon County of Morechester and Commonwealth of Massachusetts Singlewoman in consideration of one dollar paid me by John George Mitealf of said Mendon Physician the receipt whereof I do hereby acknowledge do hereby grant sell and quitclaim unto the said John George Mitealf his heirs and assigns all my right title claim and demand in and unto a certain tract of land situated in the north parish in said Mendon on the easterly side of the road leading from Elisha Woods by Elias Taft's and Welcome Staples to the road to Northbridge and bounded as follows to wit - beginning at a corner of the wall on the easterly side of said road thence running north  $35\frac{2}{3}$  west with the wall five rods to a stake and stones then North  $18\frac{1}{2}$  east eight rods to a stake and stones then south  $35\frac{2}{3}$  east five rods to a stake and stones at land of Nathan George thence south  $18\frac{1}{2}$  west eight rods bounding on land of said Nathan George to the first mentioned bound

To have and to hold the same to the said John George Mitealf his heirs and assigns to his and their use and behoof forever and I do covenant to warrant and defend said granted and quitclaimed premises to the said John George Mitealf his heirs and assigns forever against the lawful claims and demands of all persons claiming by or under me.
