QUITCLAIM DEED

WITH QUITCLAIM COVENANTS

The land with the buildings thereon situated in Mendon, Worcester County, Massachusetts, bounded and described as follows:

Being Lot 6 on plan of house lots owned by William H. Pyne, formerly owned by John T. Manson, and plan made by Henry W. Gaskill, C.E., dated September 6, 1906, and recorded with Worcester District Registry of Deeds, Plan Nook 12, Plan 44.

Also, that certain tract or parcel of land, lying southerly of and adjoining lot #6 shown on plan of house lots owned by John T. Manson at Nipmuck Park, Mendon, Mass., Sept. 1906, Henry W. Gaskill, C.E., said plan being recorded with Worcester District Deeds, Plan Book 12, Plan 44.
