Quitclaim Deed

Vicky Schofield Smith of Weatherford, Parker County, Texas, Robert W. Schofield, Jr. of Weatherford, Parker County, Texas, and Jeri-Lyn Schofield DePute of Poteet, Atascosa County, Texas, as Tenants-in-Common,

for consideration paid, and in full consideration of One Hundred Fifty-Five Thousand Dollars (\$155,000.00)

grant to: Thomas D. Hackenson, of 21 Kinsley Lane, Mendon, MA 01756
with quitclaim covenants, the land is said Mendon on the southeasterly side of Route 16
and on the shore of Lake Nipmuc, bounded and described as follows:

COMMENCING at a drill hole in a stone in the easterly line of said Route 16, at land formerly of Henry W. Gaskell;

THENCE running with the line of said road 50 feet southwesterly to a stake at land now or formerly of John T. The Manson;

THENCE with land of said Manson S. 54 degrees E. about 190 feet to the shore of Lake Nipmuc;

THENCE easterly with the shore of said Lake to land formerly of Henry W. Gaskell;

THENCE N. 54 degrees W., passing through a drill hole in a stone and with said Gaskell land, about 192 feet to the point of beginning.

Excepting from the above described premises the land taken by the Commonwealth of Massachusetts for improvement of Route 16.

Meaning and intending to convey and hereby conveying all the same premises as were conveyed to Kathleen M. Schofield and her late husband by deed of Thomas D. Hackenson et ux., which deed was dated July 11, 1962, and was recorded with the Worcester District Registry of Deeds Book 4295, Page 368.
