----- receipt whereof I do hereby acknowledge have remised released and forever  
quitclaimed and do by these presents remise release and forever quitclaim  
unto the said Cushman Thayer his heirs and assigns forever the following describ-  
ed tracts of land and buildings thereon situated in Mendon aforesaid contain-  
ing seventy seven acres be the same more or less bounded as follows viz. begin-  
ning at the South side of the town road thence S. 27<sup>3</sup>/<sub>4</sub> W. four hundred rods  
thence S. 78<sup>1</sup>/<sub>4</sub> W. eighteen rods twenty links thence Southerly a varying line  
fifty five rods and eight links thence N. 51<sup>3</sup>/<sub>4</sub> W. twelve rods thence S. 26<sup>1</sup>/<sub>4</sub>  
W. twenty six rods eleven links thence S. 28<sup>3</sup>/<sub>4</sub> E. nineteen rods seventeen
