grant sell and convey unto the said Asa Prince his heirs and as-
signs a certain piece of land situated in Dudley containing twenty
one acres two quarters and thirty seven rods and is bounded as follows
viz. beginning at the Southwest corner of the same on the Easterly side
of a town road thence South 82° 30' East fifty two rods and one half
North 9° East twenty one rods and an half thence South 81° 30' East
thirty one rods thence South 84° East nine rods and eight links
thence North 7° West thirty six rods & ten links thence South 71° 30'
West twenty six rods thence South 82° 15' West 35 rods & 16 links thence
North 5° 45' West 23 rods & three quarters to a turnpike road all by the
land of Joshua Fourtellot thence South 62° 30' West 27 rods & 20 links
by the Southerly side of said turnpike road to said town road thence
South 11° West by said town road 20 rods & 1/2 links thence South 10°
West 22 rods & an half to the bounds first mentioned. — To have
and to hold the aforegranted premises to the said Asa Prince his
heirs and assigns to his use and behoof forever and I do for my-
self my heirs executors and administrators covenant with the
