

West 5° South forty four rods to a white oak stake, by a stone wall, marked, with stones about it, then South 30° 20' East by said stone wall twenty rods and eighteen links to the first mentioned corner, containing four acres one hundred rods. And I do hereby constitute and appoint my said beloved Wife Warty Davenport, together with my Friend Seth Hastings of Mendon aforesaid Esquire, sole Executors of this my last Will and Testament, hereby revoking all former Wills by me made. -
