of Milford, County of Worcester and Commonwealth of Massachusetts,
in consideration of Six Hundred Dollars paid by Lewis B. Gaskill of
Hopedale in said County, the receipt whereof is hereby acknowledged, do
hereby remise, release and forever quitclaim unto the said Lewis B. Gas-
kill one undivided third part of three certain tracts or parcels of land
with the buildings thereon situated partly in Mendon in said County
and partly in said Hopedale and are the same premises as are de-
scribed in a deed from Leyman Daniels, Amos Daniels and Tyler
Daniels to Samuel Gaskill dated March 18th 1818 and recorded with
Worcester District Deeds Book 212 Page 147. It being premises devised by the
Will of Naum Gaskill son of said Samuel to my Mother Mary T. Gould
