

ing all & singular the matters, stipulations & conditions in the said Notes prescribed, then to enter upon & take full & exclusive possession of the afore-granted premises, & hold, manage & dispose of the same, & hold & appropriate the proceeds thereof & the income of said proceeds, all as in said Notes, also particularly set forth & prescribed. In the third place, to do keep & faithfully perform all & singular, the other matters & things in the Notes aforesaid, of & concerning the Trust hereby created, contained, prescribed & declared. And in the fourth place, to fill all vacancies in their number which may occur by death, resignation, or otherwise; and on the election of such new Trustee or Trustees, thereupon by the deed of all the surviving Trustees, to convey all the afore-granted premises to the five persons, constituting the new board of Trustees to be by them & the survivors of them, & the heirs & assigns of the survivor, forever, helden upon & subject to the same Trusts, conditions & stipulations, in all respects as herein & in the Notes aforesaid, contained & declared.

And the said Enos Goss, the party of the first part as aforesaid, for himself & his heirs, covenants with & unto the said parties of the second part part & the survivors of them & their assigns, that the afore-granted premises are free of all incumbrances; that he hath good right to convey the same, & that he & his heirs will warrant & defend the same unto the said parties of the second part & the survivors of them & their assigns, against the lawful claims & demands of all persons. And in consideration of the premises, the said Jacob Tole, David A. Grosvenor, William L. Capron, Peter Rockwood & Paul Whiting, the parties of the second part, as aforesaid, severally, not jointly, each for himself & his heirs & not for another, nor for the acts of another, nor for the acts of another covenant with the said Enos Goss, the party of the first part as aforesaid, & his executors or administrators, that they severally will well & faithfully discharge & fulfil all & singular the Trusts aforesaid according to their true intent & meaning; and for the consideration aforesaid Mary Eliza - wife of the said Enos Goss, hereby releases all right & claim of dower, in the premises. In testimony whereof, the said parties have interchangeably set their names & seals to these presents on the day & year first aforesaid.
