achusetts, in consideration of Nineteen Hundred dollars \$1900⁰⁰
paid by Mattie A. Hodges of Leominster in the County and
State aforesaid the receipt whereof is hereby acknowledged,
do hereby give, grant, bargain, sell and convey unto the
said Mattie A. Hodges, her heirs and assigns, Two certain
tracts of land with the buildings thereon situated in said
Hubbardston, being a part of the Hiram Grimes farm, so
called, the first tract being bounded as follows, viz: Be-
ginning at the southeast corner thereof on the line of the
road leading to Gardner at corner of land formerly of J. W.
Norcross; thence S. $67\frac{1}{2}^{\circ}$ W. 36 rods, 2 links by said Norcross
land to land formerly of Samuel S. Gleason; thence S. $61\frac{1}{2}^{\circ}$
W. 12 rods, 2 links; thence N. 28° W. 10 rods 20 links; thence
S. $62\frac{1}{4}^{\circ}$ W. 31 rods 15 links all by said Gleason's land to
