

as follows (to wit) Beginning at the point where the County road leading from Worcester to Providence intersects the County road (formerly a turnpike) leading from Hartford to Boston thence ~~running~~ running South $83\frac{3}{4}^{\circ}$ West seven rods to a stake and stones and bounding Southerly on the last mentioned road thence running North $23\frac{1}{3}^{\circ}$ West seven rods and twelve links to stones on a rock thence running North 68° East six rods and five links to a stake and stones on the Westerly side of said Worcester and Providence road the two last lines bounding on land of Mr S Hastings Charles C P Hastings and Mary McKayward thence running South $25\frac{3}{4}^{\circ}$ East nine rods and thirteen links to the first mentioned point or place of beginning and bounding Easterly on said Worcester and Providence road It being the same lot of land which is described in the deed of Seth Hastings to the said Jabez Aldrich and Caleb Hayward recorded in the Registry of Deeds for said County of Worcester Book 244 Page 607

Therefore know ye that I the said Ebenezer McKayward as administrator as aforesaid by virtue of the power and authority in me vested as aforesaid and in consideration of the aforesaid sum of thirteen hundred and seventy five dollars to me paid by the said Jabez Aldrich the receipt whereof I do hereby acknowledge do hereby give grant bargain sell and convey unto him the said Jabez Aldrich his heirs and assigns the estate herein above mentioned and described or howsoever the same is reputed to be bounded or described. To Have and to hold the aforegranted premises with all the privileges and appurtenances to the same belonging to him the said Jabez Aldrich his heirs and assigns forever to his and their use and behoof forever And I the said Ebenezer McKayward administrator as aforesaid do hereby covenant with the said Jabez Aldrich his heirs and assigns that I was lawfully authorized and empowered to make sale of the same as aforesaid and that I have pursued the requisitions of law in this behalf.

In witness whereof I the said Ebenezer McKayward as administrator as aforesaid have hereunto set my hand and seal this twenty seventh day of May in the year of our Lord one thousand eight hundred and thirty three
