Know all men by these presents, that I, Charles Davenport, of Mendon, in the County of Worcester, and Commonwealth of Massachusetts, Seaman, in consideration of one hundred dollars, paid by David Davenport, of said Mendon, in said County, guardian of the minor children of George L. Davenport, late of said Mendon, deceased, the receipt whereof I do hereby acknowledge, do give, grant, sell and convey unto the said David Davenport, the following described piece of real estate, situated in said Mendon, with all the privileges to the same belonging, bounded as follows, to wit: Beginning at the Northeastly corner, on the Westerly side of the Providence and Worcester road, at the Southeastly corner of Liberty Goss's land; thence running Westerly bounding Northerly by said Goss land about eighty eight rods to a corner, at Otis Thayer's land; thence turning Southerly bounding Westerly by said Thayer's land to a corner; thence turning Easterly, bounding Southerly by said Thayer's land to a corner at the grave yard; thence turning Northerly and then Easterly by said grave yard to a corner at George Davenports land; thence turning and running Northerly, bounding Easterly by said Davenports land to a corner; thence turning Easterly, then Northerly, then Easterly by said Davenports land to a corner at the road; thence turning Northerly, bounding Easterly on said road to the point of beginning; containing forty acres, more or less.
