Two certain tracts or parcels of land, with the buildings thereon, situated in Mendon, Worcester County, Massachusetts, and being more particularly bounded and described as follows to wit:

TRACT 1. A. Latham, Nov. 1909" which said plat is filed with Worcester District Deeds, Plan Book 18, Plan 1, reference to which is hereby had for a further description.

Being the same premises conveyed in deed of Bodwell Land Company to Luigi Leoncini and Annunziata Leoncini, dated July 22, 1922, recorded with Worcester District Deeds, Book 2275, Page 577.

Meaning and intending to hereby convey any and all the same premises conveyed to this grantor by deeds of Rose A. Brown et alii, dated September 24, 1959, recorded with said Deeds, Book 4079, Page 245 and deed of said Rose A. Brown et alii to this grantor, dated May 2, 1960, recorded with said Deeds as Instrument No. 13639.

The grantor reserves the right to live in the house located on the granted premises for and during the term of her natural life.
