Together with the right to the grantee, its successors and assigns, to draw water from an artesian well, located on adjoining land of George Thomas and Eva Thomas, for use in operating a gasoline service station, the use, however, of said water to be subordinate to the rights of said George Thomas and Eva Thomas, their heirs and assigns; and provided further that the said water used by the grantee, its successors and assigns, be compensated for by paying to said George Thomas and Eva Thomas, their heirs or assigns, a certain amount as per the following rates: forty-five cents per 100 cubic feet for the first 5000 cubic feet per month, then 18 cents per 100 cubic feet in excess of said 5000 cubic feet per month. Provided further, that this right to draw water as aforesaid is subject to the following condition: that if the Town of Mendon makes water available to said grantee, its successors or assigns, then said right to draw said water shall cease.
