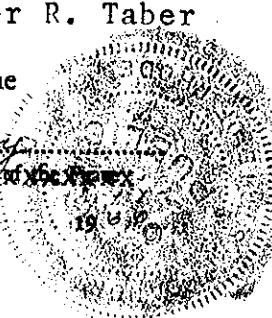

CERTIFICATE OF AGREEMENT

At a joint meeting held by the Smithfield Monthly Meeting of Friends at Woonsocket, R. I., and the Trustees of the Swan Dale Cemetery Association on June 29, 1962, at Mendon, Worcester County, Massachusetts, it was unanimously agreed as follows:

"That the Smithfield Monthly Meeting of Friends at Woonsocket, R. I. would deed to the Swan Dale Cemetery Association the cemetery known as the "Quaker Cemetery", being those premises described in deed of Moses Aldrich, et al. to George Aldrich, et ali., Agents, dated July 4, 1758, recorded with Worcester District Deeds, Book 46, Page 41; and that said premises shall continue to be used only for burial purposes."

At a special meeting of the Smithfield Monthly Meeting of Friends at Woonsocket, R. I., held on September 30, 1962 at Woonsocket, R. I., it was unanimously agreed as follows:

"That Nellie M. Fisher of Woonsocket, Rhode Island and Lester R. Taber of said Woonsocket, be and hereby are designated Trustees to succeed George Aldrich, George Smith and Joseph Allen, named as Agents in a deed from Moses Aldrich, et al. to said George Aldrich, et ali., Agents, dated July 4, 1758, recorded with Worcester District Deeds, Book 46, Page 41; and that they be and are hereby authorized to sign, seal, acknowledge and deliver in behalf of the Smithfield Monthly Meeting of Friends at Woonsocket, R. I., a deed of the "Quaker Cemetery", so-called, in Mendon, Worcester County, Massachusetts, to the Swan Dale Cemetery Association, being those premises described in said deed from Moses Aldrich, et al. to George Aldrich, et ali., Agents, upon such terms and conditions as said parties shall deem necessary or advisable as conclusively evidenced by their execution thereof."
