Also one other tract or parcel of land located on the easterly side of the road leading from South Milford to Batesville, (formerly the road from Milford to Bellingham), in Mendon, Worcester County, Massachusetts, bounded and described as follows to wit:-

Beaton; thence turning an interior angle of 89° 52' and running S. 81° 20' E. about one hundred thirty six feet to the westerly side of the New State Highway laid out in 1931; thence southerly with the westerly side of said New State Highway to land of Joseph Anesta, et ux; thence S. 73° W. by said Anesta Land to the easterly side of said road leading from South Milford to Batesville; thence N. 29° W. with said road one hundred thirteen feet to the point of beginning. Being a part of the premises described in Deed of Franklin W. Pond to George A. Beaton, dated August 23, 1916, and recorded with Worcester District Deeds, Book 2119, page 433; also being a part of those premises described in deed of Berigno Leone, et ux, to Lila B. Beaton, recorded with said Worcester District Deeds, Book 2486, page 89.

Being the same premises conveyed to us by deed of Thomas E. Miller, dated October 26th, 1932, and recorded with Worcester District Deeds, Book 2574, page 451.

The premises are conveyed subject to taxes of the Town of Mendon which taxes the Grantees agree to assume and pay."
