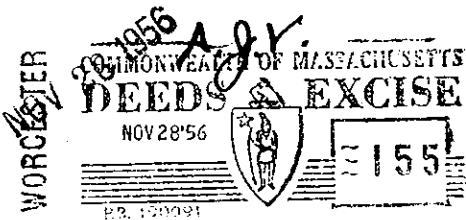
A certain parcel of land situated on the easterly side of Bates Street in said Mendon and being more particularly bounded and described as follows:-

Beginning at the northeasterly corner of the granted premises at a drill hole in a stone in the wall in the easterly line of said Bates Street, said point being the southwesterly corner of land of one Townsend;

- THENCE S. 82° 44' E. and bounding on said Townsend land, 151.8 feet to a stake;
- THENCE S. 15° 30' E., 100 feet to a stake;
- THENCE N. 82° 44' W., 153 feet to an iron pin in the easterly line of said Bates Street, said last two lines bounding on other land of the grantors;
- THENCE N. 15° 30' W. along the easterly line of said Bates Street and passing through a Worcester County Highway Bound, 100 feet to the point of beginning.

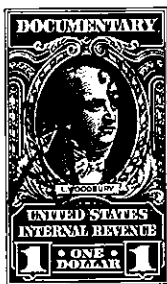
