## **QUITCLAIM DEED**

I, Robert W. Loftus, Jr., being unmarried of Cape Road, Mendon, MA

for consideration of less than One Hundred Dollars and 00/100 (\$100.00) paid,

grant to Elizabeth J. Loftus, Individually, of 18 Cape Road, Mendon, Massachusetts,

with Quitclaim Covenants

A certain parcel of land, with the buildings thereon and all the privileges and appurtenances thereto belonging: situated in Mendon, Worcester County, Massachusetts, bounded and described as follows:

**BEGINNING** at the Northwesterly corner of the granted premises and at Cape Road, a public way in Mendon, Worcester County, Massachusetts, at a drill hole in a concrete bound;

THENCE North 68° 55' 33" East and bounded northerly by land of Joseph McEwen, 538.93 feet to the corner of a stone wall;

THENCE South 34° 57' 00" East and bounded easterly by said McEwen land along the line of said wall, 197.88 feet to a corner of said wall;

THENCE South 64° 52' 10" West and bounded southerly in part by said McEwen land and the land of one Eckart and Pepe, 194.77 feet to a point at the end of said wall;

THENCE South 76° 51' 50" West and bounded southerly by said Eckert and Pepe land, 108.22 feet to a point at the northeasterly corner of parcel #2;

THENCE North 16° 10' 43" West and bounded westerly by said parcel #2, 70 feet to a point at the northwesterly corner of said parcel #2;

THENCE South 75° 43' 04" West and bounded southerly by said parcel #2, 300 feet to a point being the southeasterly corner of the granted premises at Cape Road, a public way in Mendon, Worcester County, Massachusetts;

**THENCE** North 16° 24' 15" West and bounded westerly by said Cape Road, 86 feet to the point of beginning.
