"The land, with the building thereon, located on the northerly side of North Avenue in said Mendon, being all the same premises conveyed by and described in deed of Lora E. Williams to said Claud S. Shaunessy, dated October 4, 1911, and recorded with Worcester District Deeds, Book 1973, page 583, and bounded and described in said deed as Follows, to wit:-

Thence S. 20° 26" E. 58 feet;

Thence N. 49° 34" E. 511.39 feet.

Said granted premises shall be restricted as follows:
