Blase, for myself, & for my heirs, executors and administrators, do covenant with the said George Mowry, his heirs and assigns, that I will warrant and defend the afore-described premises, to the said George Mowry, his heirs and assigns forever, against the lawful claims and demands of all persons, claiming by, through, or under me, and none other.
