Thereby give unto my Daughter Water Wood, wife of Jesse Wood the sum of Sixty Dollars. - The above sums which I give my said Daughters Alice, Mary, Anne, Sarah and Water are to be paid by my Executors in one year after my decease. - I also give them my said Daughters, one silver Table Spoon each, the above sums and Spoons to be their share out of my Estate.

I give and bequeath unto my two young Daughters Amy Mowry and Patience Mowry, the sum of Fifty Dollars each to be paid by my Executors in one year after my decease; and it is my wish and desire that my Wife be appointed Guardian to them the said Amy and Patience, if I should die before they arrive to the age of Twenty one year in case she is living.

As to the rest, residue and remainder of my Personal Estate of what kind or nature soever including money at Interest, Stock of Cattle, Farming Tools &c I give and bequeath the same to my Sons Samuel Mowry, Caleb Mowry, Israel Mowry and Robert Mowry, the same to be equally divided between them after my just Debts, funeral charges and the Legacies herebefore mentioned have been first paid by my Executors out of the same.

And Lastly, I hereby appoint Caleb Mowry & Samuel Mowry my two Sons to be the Executors of this my last Will and Testament.
