First.

I also give and bequeath to my second Son Seth Chapin Jr., the sum of five Dollars.

I also give and bequeath unto my second Daughter Ruth Pisk, the sum of five Dollars. Which said several legacies or sums of five Dollars, I will and order to be paid within one year after my decease.

I also give and bequeath unto my youngest Daughter, Betsy Brown, my second best Bed and all the furniture belonging to the same, and also the sum of one hundred Dollars, to be paid to her in the following manner, to wit.

Twenty Dollars in one year after my decease, twenty Dollars in two years after my decease, twenty Dollars in three years after my decease, twenty Dollars in four years after my decease, and twenty Dollars in five years after my decease.

And Lastly, As to all the rest, residue and remainder of my Personal Estate, Goods & Chattels of what kind and nature soever, I give & bequeath the same, to my youngest Son Moses S. Chapin, whom I hereby appoint sole Executor of this my last Will & Testament; hereby revoking all former Wills by me made.

In Witness whereof, I have hereunto set my hand and seal, the twenty ninth day of August, in the year of our Lord, One thousand eight hundred & twenty seven.

Named, sealed, published and declared by the above named Seth Chapin to be his last Will & Testament, in presence of us, who at his request & in his presence, have hereunto subscribed our names as Witnesses to the same.
