 England Yeoman, Sendeth Greeting. Know ye that I the said Benjamin Wheelock
 for and in consideration of that Particular Love and Affection which I have and do
 bear toward my well beloved Son Silas Wheelock of Inwood aforesaid Husband
 man and to promote his Settlement and Accommodation in the World and for divers
 other good Causes and Considerations me hereunto moving have given granted Allocated
 conveyed confirmed and confirmed and by these presents do fully freely Clear
 ly and absolutely Give grant Allocated convey and Confirm unto my said son
 Silas Wheelock his heirs and Assigns forever a certain Tract or parcel of Land
 Situate lying and being in the South part of Caleb Hill so called in Inwood on
 aforesaid said Tract or parcel of Land containing by Estimation Eighty Acres be-
 lieved to be more or less and is better and bounded as followeth vizt at the North
 West Corner with an heap of Stones thence bounded by a Road leading to John
 Leggs and so by a Road till it come to an heap of Stones at the South West Corner
 thence southwardly by Land that was lately Capt Thomas Thayers till it come to the
 Road laid out leading from a place called Dams Pond Swamp to David Thayer thence
 running with a Road to Land of David Thomas Sandford and so by his Land by a line
 of marked Trees thence to another heap of Stones being at North East Corner thence
 Westwardly by my own Land by a line of marked Trees to a bound first mentioned
 Together with all such Rights profits and Appurtenances as in any wise
 Appertain. I do give unto and to any part of the same to have and to hold the
 above granted premises together with all and singular Appurtenances thereof unto
 him the said Silas Wheelock his heirs and Assigns as a good sure and Indefeasible Estate of
 Inheritance in Fee simple forever free and Clear and Cleanly legitimated by change
 of from all and all manner of former and other Gifts grants bargains Sales titles
 Troubles Charges and Incumbrances whatsoever that have been committed done or suffered to
 be done by me the said Benjamin Wheelock my heirs or Assigns at any time or times
 before the sealing and delivery of these presents and that the said Silas Wheelock his
 heirs and Assigns shall and may from hence forth forever hereafter by force
 and virtue of these presents Lawfully Quietly and peaceably Have Hold
 occupy
