

by a direct line by the Southwest side the Chimney fifteen rods to a garden wall thence North fifty degs, East two & half rods to a stone wall thence north seven deg, West fifty six rods & a half thence South twenty four deg, West twenty one rods & a half on James Millers land thence running South six & a half deg, East twenty eight & a quarter rods then South fifteen & a half deg, East five rods thence North twenty nine deg, East ten rods thence South ten deg, East ten & a quarter rods then North eighty two & a half deg, East twelve & a quarter rods thence South fourteen deg, East twenty rods thence South twenty eight deg, East thirty one rods thence North fifty nine deg, East to the first bounds in front of the house containing twenty eight Acres, we also set of to Benjamin three acres of Swamp land at the Southwest corner of said farm adjoining the above premises Joseph Torrey land & a road leading to the South Parish at the North end of said Swamp to be of equal width at each end to make the above three acres we also set of to said Benjamin five Acres of Wood land by the same more or less bounded as follows beginning at a corner of Elijah Haywards land & running with a direct line with said Haywards Northeast line to Akers Allens land bounding on said Allens land to the road leading to the South Parish in Mendon thence on said road to Elijah Haywards land thence on said Haywards land to the first bounds mentioned — we also set of to the said Benjamin as a privilege one third part of the Barn & one third part of the Barn yard at the Southwest end of said Barnyard also one third part of the Corn crib with a privilege to go to a well of water the North of the barn we also set of as a privilege to the said Seth Wheelock a privilege to go to the well in front of the house on Benjamins part & likewise a privilege in the oven in Benjamins part to bake when they please
