Wheelock of said Mendon yeoman the receipt whereof I do acknowledge  
do hereby remise release and forever quitclaim and by these presents do  
give grant sell and forever quitclaim unto the said Seth Wheelock  
& Calvin Wheelock and to their <sup>heirs</sup> and assigns all and singular my right  
title claim interest and demand in and unto the real estate of which  
my Honoured Father Silas Wheelock late of said Mendon Esquire  
did give and possess lying in Mendon aforesaid excepting the  
land and buildings set off to Hannah Wheelock my Honoured Mother out  
of said Estate for her support during her natural life — To have and  
to hold the said granted and released premises with the appurtenances to  
them the said Seth Wheelock and Calvin Wheelock their heirs and assigns  
forever and I the said Luther Wheelock for myself my heirs executors  
and administrators do covenant and engage the above demised and  
released premises unto the said Seth Wheelock and Calvin Wheelock  
their heirs and assigns forever hereafter to warrant and defend the same  
against myself my heirs executors & Administrators or any person or
