Mann Lydia To all men by these presents, that I Lydia Mann of Mendon in the County  
to of Worcester and Commonwealth of Massachusetts bsd. woman. In  
Nath'l Inman &c. Consideration of the sum of sixteen hundred dollars paid by Nathaniel  
and Buffum Inman of Burrlivill in the County of Providence and  
State of Rhode Island Yeomen. the receipt whereof I do hereby ackn-  
owledge, do hereby give, grant, sell and convey unto the said  
Nath'l and Buffum Inman a certain farm situate in the first  
parish in said Mendon and on Caleb's Hill (so called) and the  
farm that Seth Wheelock formerly owned, bounded as follows, viz  
beginning at the northeast corner of said farm and at the corner  
of Mariah Taft's pasture then southwardly and bounding ~~south~~  
easterly by Nath'l K. Melens land to the Town road, then across  
said road a southerly course and bounding easterly by Joel How-  
ard's land as the wall and fence now standy including a privilege to  
a certain spring of water about one rod east from a direct course  
sufficient for a watering place for cattle, and not to the injury  
of watering the other side, then westerly from the corner of said wall  
about five rods to a stake and stones by wood land of said Joel  
Haywards, then southerly by said Joel Howard wood land to a  
heap of stones, then westerly bounding southerly by said Howard's  
wood land to Andrew Penniman's land, then by said Penniman's  
land to Ahas Allen, then by said Allen's land to the Town road  
leading from the first parish meeting house to the second, then  
by and with said road a northerly course to Caleb Mowrey's  
land, then easterly bounding northerly by said Mowrey's land to  
the southeast corner of said Mowrey's land, to Thurber War-  
field's land to the southeast corner of said Warfield's land  
then westerly and bounding southerly on said Warfield's land to  
Dennis Wheelock's land and said Warfield's land then northerly on  
said Warfield's land then westerly and bounding by said Warfield  
to the meadow, then northerly bounding southerly by said Warfield  
land to the northeast corner of said Warfield's land then westerly  
across said meadow and bounding southerly by said Warfield  
land to the said Town road, then northerly by and with said
