Aldrich & Inman know all men by these presents that I Chiron Aldrich, of Mendon, in the County of Worcester and Commonwealth of Massachusetts - woman in consideration of thirty-four Nathaniel Inman dollars - fifty six cents paid by Nathaniel Inman of the aforesaid Mendon woman the receipt whereof I do hereby acknowledge do hereby give grant sell and convey unto the said Nathaniel Inman his heirs and assigns two certain pieces or parcels of Woodland situated in said Mendon and Southeast from said Inman's dwelling house the first piece contains six acres ^{six} sixty square rods and is bounded and butted as follows to wit Beginning at a heap of stones at the Northeast corner of said tract thence S. 64° W. 77^{1/2} rods to stake and stones bounding north on said Inmans land thence S. 81° E. 11 rods to a heap of stones, thence N. 88° E. 5 rods and thence to a heap of stones thence N. 81° 25' E. 70^{1/2} rods to the north side of a pyramidal shaped stone marked B. in a ledge of rocks these three lines bound south on Samuel Gashills land thence N. 33^{1/2} W. 25 rods to the first bound bounding easterly on land this day purchased by Nathan Aldrich - The second piece being in a triangular shape and situated North of the former contains one half acre and is bounded as follows viz) Beginning at the heap of stones first above mentioned at the South end of this piece thence N. 13^{1/2} W. 32^{1/2} rods to a heap of stones, thence N. 64^{1/2} E. 5 rods thence to a corner of wall at Caleb W. Allens land these two lines bound the first west and the other north on said Inmans land thence S. 5° E. 34 rods to the first bound, bounding east on the said Nathan Aldrich's land above mentioned -

To have and to hold the afore granted premises to the said Nathaniel Inman his heirs and assigns to his and their use and behoof forever And I do for myself my heirs executors and administrators covenant with the said Nathaniel Inman his heirs and assigns that I am lawfully seized in fee of the afore granted premises that they are free of all incumbrances; that I have good to sell and convey the same to the said Nathaniel Inman; and that I will warrant and defend the same premises to the said Nathaniel Inman his heirs and assigns forever against the lawful claims and demands of all persons - In witness whereof I the said Chiron Aldrich and Sally Ann Aldrich wife of the said Chiron in token of my voluntary relinquishment of my thirds and right of donor in the above described and bargained premises have hereunto set our hands and seals this first day of September in the year of our Lord one thousand eight hundred and thirty -
