I, George A. Davis of Mendon, Worcester County, Massachusetts being unmarried, for consideration paid, grant to John Civetti of Newton, Middlesex County, Massachusetts, with W A R R A N T Y covenants the land in the westerly part of MENDON, on the northeasterly side of a proposed right of way located off the northerly side of the road formerly called the Ninth Massachusetts Turnpike, now called Hartford Avenue West, in said Mendon, being bounded and described as follows: Beginning at a bound at the southeasterly corner of the granted premises on the northeasterly side of the proposed right of way and at the southwesterly corner of land this day conveyed to Jeremiah B. Driscoll; thence Northeasterly by said Driscoll land about 125 feet to a bound at land; now or formerly, of Carl Taft; thence Northwesterly by said land, now or formerly, of Carl Taft about 48 feet to land, now or formerly, of one Robinson; thence Southwesterly by land, now or formerly, of said Robinson about 167 feet to a bound on the northeasterly side of proposed right of way; thence Southeast-erly by the northeasterly side of said proposed right of way about 132 feet to the point of beginning.

Together with a right to pass and repass over and upon said proposed right of way from said Hartford Avenue West to the granted premises.

Being a part of those premises conveyed to me by deed of Henry W. Gaskill, dated November 22, 1937 and recorded with Worcester District Deeds, Book 2711, Page 76.
