 to a heap of stones at the south west corner of said wood lot still westerly
 by Andrew Pommers' land to a heap of stones on a rock at the corner
 of said Pommers' land and Seth Wheelock's land thence northerly
 by said Wheelock's land to a heap of stones by a stump the same point by
 Wheelock's land to Wheelock's fence thence easterly by Wheelock's land as
 the fence and wall now stands continuing the same point by Wheelock's
 land to a stake and stones thence northerly by said Wheelock's land
 to a heap of stones at the northwest corner of said lot thence easterly by
 said Wheelock's land to the corner of Alex Allen's land thence easterly
 by said Allen's land as the wall now stands to the first mentioned
 bounds reserving for my honoured Mother M^{rs} Sarah French the im-
 provement of the land and buildings which was given to her by
 my honoured Father M^{rs} French in his last will and testament to
 improve and also reserving to my sister Mary French the improve-
 ment of the west room in my dwelling house and two rods of wood
 standing as long as she remains single or unmarried agreeable
 to said Will the above mentioned wood is to be taken in south wood
 lot after my Honored Mother's decease. I also convey to said Zimri to
 his heirs and assigns a privilege to pass a road from the new town
 road leading to Seth Wheelock through Alex Allen & Seth Wheelock's
 land to said Wood lot by the S^r Zimri putting up the bars as well as he
 finds them.

So I have and to hold the same to him the said Zimri his heirs
 and assigns to them and their use and behoof forever and I do covenant
 with the said Zimri his heirs & assigns that I am lawfully seized in
 fee of the premises that I have good right to sell and convey the same to
 the said Zimri his heirs and assigns forever against the lawful
 claims and demands of all persons - In witness whereof I have here-
 unto set my hand ^{with my wife Eunice} and seal this twenty fifth day of April in the
 year of our Lord 1807
