QUITCLAIM DEED

Grant to **Alison Lundin and Joseph Filion**, <sup>Joint Tenants</sup> Right of Survivorship now of 26 Millville Road, Mendon, Massachusetts 01756

With QUITCLAIM COVENANTS

Two certain tracts, or parcels of land, situated on the southerly side of Millville Road in Mendon, Worcester County, Massachusetts, together with the buildings thereon, bounded and described as follows:

PARCEL 1

Beginning at a stake on the southerly located line of said Road, which stake is the northeasterly corner of land now or formerly of James H. Grant, and at land, now or formerly of Thomas F. Kelley;

THENCE: S. 58° 52' W. seventy (70') feet by said Millville Road to a drill hole in a stone at land now or formerly of said Grant;

THENCE: S. 27° 30' E., a distance of two hundred (200') feet to a point at a stake, said stake is located at the southwesterly corner of said land;

THENCE: N. 58° 52' E., a distance of seventy (70') feet to a point, said point being at the southeasterly corner of the lot herein conveyed at land now or formerly of Thomas F. Kelley;

THENCE: N. 27° 30' W., a distance of two hundred (200') feet by a wire fence and land, now or formerly of said Kelley to a stake at said Millville Road being the place of beginning.

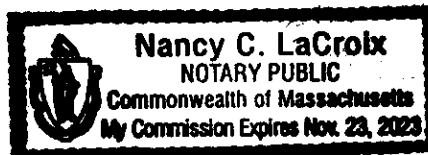

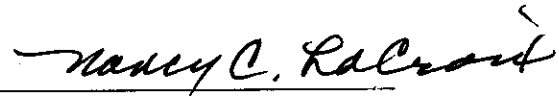
