A certain tract or parcel of land situated on the easterly side of the Millville Road in said Mendon and being more particularly bounded and described as follows, to wit:-

Beginning at a corner of stone walls on the easterly side of said road and at land of one Goss, formerly of the grantor; thence easterly by a stone wall 165 feet more or less to the end of said wall; thence easterly 70 feet to the end of a stone wall; thence northeasterly in part by a stone wall 498 feet more or less to a stone wall; thence southerly by a stone wall 537 feet to an iron pipe at the intersection of stone walls, the last four lines bounding on said Goss land; thence northeasterly by a stone wall and land now or formerly of one Kinsley 983 feet more or less to an iron pipe at the intersection of stone walls; thence northwesterly by a stone wall and land now or formerly of one Wiersma, formerly of one Millis, 550 feet more or less to a drill hole in said stone wall; thence continuing northwesterly by said stone wall and said Wiersma land 90 feet more or less to an iron pipe in said stone wall; thence S. 60°W. by other land of the grantor 269.2 feet to an iron pipe; thence S. 30° E. 170.6 feet to a drill hole in a stone wall; thence S. 39°05' W. by a stone wall 49.5 feet to an angle in the wall; thence S. 12°35'E. by said stone wall 11.40 feet to a corner of walls; thence N. 89° 55'W. in part by a stone wall 425 feet more or less to a drill hole in another stone wall, the last four courses bounding on land of one Leslie C. Childs, formerly of the grantor; and thence southwesterly by a stone wall and land of one Comolli, formerly of the grantor 83 feet to a drill hole in said stone wall; thence southwesterly and westerly by land of one Grant and in part by a stone wall, being the northerly line of an old lane, 628 feet to the easterly side of said road; and thence southerly by said Millville Road 21 feet more or less to the point of beginning.
