## With QUITCLAIM COVENANTS

A certain tract or parcel of land located on the northerly side of the road known as Hartford Avenue (West) in said Mendon and being shown on plan of land entitled, "Land in Mendon, Mass. William J. Hazard, Owner, Scale 1" = 100' May 1957 Milton C. Taft, Civil Engineer Uxbridge, Mass."
