Grant to CHARLES J. STOCKS and JUDITH A. STOCKS of Uxbridge, Worcester County, Massachusetts, as joint tenants a 25% interest, to BARBARA W. CUNNINGHAM, of Franklin, Norfolk County, Massachusetts, a 25% interest, to EDWARD J. SULLIVAN, JR. of Holliston, Middlesex County, Massachusetts and EDWARD J. SULLIVAN III, of Franklin, Norfolk County, Massachusetts, as joint tenants, a 25% interest and to EDWARD J. SULLIVAN III, a 25% interest in the property described herein below,

WITH QUITCLAIM COVENANTS

A certain tract or parcel of land with the buildings thereon situated on the northwesterly side of the Uxbridge Road in Mendon, Worcester County, Massachusetts, and being more particularly bounded and described as follows:

BEGINNING at the southeasterly corner of the granted premises at a point in the northwesterly location line of said Road, at a point in a stone wall and at land of one Smith;

THENCE southwesterly by the northwesterly location line of said Road, 271 feet, more or less, to a point;

THENCE N. 27° 21' W., by land now or formerly of one Fantini, 320 feet, more or less, to a point in the Mendon-Uxbridge Town line;

THENCE N. 0° 31' W., by said Town Line, 278 feet to a point on a stone wall;
