A certain tract or parcel of land situated on the easterly side of Blackstone Street in Mendon, Worcester County, Massachusetts, and being all the same premises shown on plan entitled "Land of Dominik Ziska Mendon, Mass. Scale 1" = 50' Jan. 24, 1975. John R. Andrews, Jr. ", said plan filed in the Worcester District Registry of Deeds, Plan Book 409 Plan 29, and being more particularly bounded and described on said plan as follows:-

Beginning at a drill hole in iron pipe at the northwesterly corner of the premises herein described and at land of one Daige, said pipe being 150 feet from a wall,

THENCE along said Daige land, N. $89^{\circ} 40' 50''$ E., 701.22 feet to an iron pipe and clearing of International Telephone and Telegraph Company Easement;

THENCE along said Easement, S. $16^{\circ} 18' 20''$ W., 150.00 feet to an iron pipe;

THENCE S. $89^{\circ} 37' 20''$ W., along other land now or formerly of Ziska 617.05 feet to an iron pipe at said Blackstone Street, said iron pipe being 154.38 feet from another iron pipe; and

THENCE along the easterly side of said Blackstone Street and along face of wall, N. $16^{\circ} 23' 40''$ W., 150.00 feet to the point of beginning.

Containing 2.176 acres, more or less, according to said plan.

Meaning and intending to convey and hereby conveying the same and all the same premises as were conveyed to us by deed of Dominik Ziska, dated February 28, 1975, recorded with said Deeds, Book 5677, Page 125.


